Application for Approval of Interconnection Agreement Amendment



The Amendment was agreed to by the Applicant and Alltel Communications Inc. to extend the term of the interconnection agreement.


WHEREFORE, the Applicant respectfully requests that the Commission enter an Order approving the Amendment to the interconnection agreement.



**AMENDMENT NO. 1 TO
WIRELESS INTERCONNECTION AND RECIPROCAL
COMPENSATION AGREEMENT
BETWEEN
CLARKS TELECOMMUNICATIONS CO.
AND
ALLTEL COMMUNICATIONS, INC.**

This Amendment No. 1 ("Amendment") modifies the terms of the Wireless Interconnection and Reciprocal Compensation Agreement between Alltel Communications, Inc. ("Alltel Wireless") and Clarks Telecommunications Co. ("RLEC").

RECITALS

WHEREAS, Alltel Wireless and RLEC entered into a Wireless Interconnection and Reciprocal Compensation Agreement with an effective date of November 1, 2003 that was approved by the Nebraska Public Service Commission (the "Commission") on April 27, 2004, as referenced in Application No. C-3165 (the "Agreement"); and

WHEREAS, the Parties wish to amend the Agreement in accordance with the terms and conditions contained herein.

AGREEMENT

NOW THEREFORE, in consideration of the mutual agreements contained in this Amendment and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Extension of Term: Section 8.1 of the Agreement is hereby deleted in its entirety and shall be replaced by the following: Subject to the provisions of Section 14, the extended term of this Agreement shall be to and including August 31, 2008 (the "Extended Term"). This Agreement shall continue in force and effect thereafter, on a month-to-month basis, until replaced by another agreement or terminated by either Party upon sixty (60) days written notice to the other.
2. Effective Date of Amendment: This Amendment shall be deemed effective as of the later date of signature hereof by the parties.
3. Defined Terms; Ratification of Agreement: Unless otherwise defined herein, all capitalized terms used in this Amendment shall be defined as provided in the Agreement. Except as expressly amended pursuant to the terms of this Amendment, the Parties hereby ratify and confirm all other terms and conditions of the Agreement.


