PETITION OF FORMAL INTERVENTION

COMES NOW, Constellation NewEnergy-Gas Division, LLC (“CNEG”) and submits this Petition of Formal Intervention pursuant to the Rules of Commission Procedure, NEB. ADMIN. CODE, Title 291, Chapter 1, Commission Rule 015. In support of this Motion, CNEG states as follows:

1. On August 10, 2015, SourceGas Distribution LLC (“SourceGas Distribution”), Rocky Mountain Natural Gas LLC (“Rocky Mountain”), SourceGas LLC (“SourceGas”), and SourceGas Holdings LLC (“SourceGas Holdings”) (collectively “SourceGas Companies”) and Black Hills Utility Holdings, Inc. (“BHUH”) filed a Joint Application for All Necessary Authorizations and Approvals for BHUH to acquire SourceGas Holdings (the “Application”).
2. CNEG hereby files this Petition of Formal Intervention in this proceeding on the grounds that it supplies natural gas to customers in the Choice Gas Program in Nebraska. Therefore, the Application will have a direct and substantial impact on CNEG.
3. CNEG’s particular interests will not be adequately represented unless CNEG is allowed to intervene.
4. Intervention by CNEG is timely in this docket.

5. For good cause shown CNEG is an interested party and requests permission to fully participate in this docket as a Formal Intervener, including right to have notice, appear at the taking of testimony, produce and cross examine witnesses and be heard on the argument of the case.


