AFTER DUE INVESTIGATION, it is hereby certified that the above- named carrier has complied with all applicable provisions of Neb. Rev. Stat., Sections 75-301 to 75-322.04, (Reissue 2014), and the requirements, rules and regulations prescribed thereunder and, therefore, is entitled to receive authority from the Nebraska Public Service Commission to engage in transportation in Nebraska intrastate commerce as a motor carrier.

IT IS CERTIFIED, that pursuant to the Commission's Order the said carrier be, and it is hereby, issued this Certificate of Public Convenience and Necessity as evidence of the authority of the holder to engage in transportation in Nebraska intrastate commerce as a common carrier by motor vehicle; subject, however, to such terms, conditions and limitations as are now, or may hereafter be, attached to the exercise of the privileges granted to the said carrier.

AND IT IS FURTHER CERTIFIED, that the transportation service to be performed by the said carrier in Nebraska intrastate commerce shall be as specified below:

SERVICE AND TERRITORY AUTHORIZED: Transportation of passengers by bus statewide Nebraska. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.
SUPPLEMENT 1: Passengers by luxury or stretch limousine between points in Otoe, Cass, Johnson, and Nemaha counties and between points within said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized. HHS
SUPPLEMENT 2: COMMON: Passengers by luxury limousine service between points in Richardson County, and between points within said county, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTION: The transportation of railroad train crews and their baggage is not authorized.
SUPPLEMENT 3: COMMON: Transportation of passengers as a common carrier in limousine service by luxury or stretch limousine between points in Gage, Pawnee, Jefferson, Thayer, Fillmore, Saline, York, Seward counties, and between points within said counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. The Department of Health and Human Services, such as, but not limited to, FHC Option

Partners and Curtis and Associates, and/or of persons in capacity as such clients and/or persons in the custody of the Nebraska Department of Corrections, in capacity as such clients, and/or persons in custody, is not authorized.

SUPPLEMENT 4: COMMON: Transportation of passengers as a common carrier in limousines service by luxury of stretch limousine between points in Lancaster County and between points within said county, on the one hand, and, on the other hand, points in Nebraska over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. The governmentally financed transportation of clients of the Nebraska Department of Health and Human Services, such as, but not limited to, FHC Options, Partners, and Curtis and Associates, and, or other persons in capacity as such clients and/or persons in the custody of the Nebraska Department Of Corrections, in capacity as such clients, and/or persons in custody is not authorized.

SUPPLEMENT 4: Transportation of passengers and their baggage in Special Party and Charter Bus operations in the State of Nebraska Over irregular routes. (GF2)
