BY THE HEARING OFFICER:

On June 1, 2020, Black Hills Nebraska Gas, LLC, d/b/a Black Hills Energy ("Black Hills" or "Applicant") filed an application seeking a general rate increase.

A protest was filed by the Nebraska Public Advocate ("PA") on June 10, 2020, and was granted on June 29, 2020. The Public Alliance for Community Energy ("ACE") and the Nebraska Municipal Power Pool ("NMPP") also filed motions to intervene in this matter on June 29, 2020. The International Brotherhood of Electrical Workers Local 244 ("IBEW") also filed a motion to intervene on July 3, 2020. Each of these interventions was granted on July 10, 2020.

Procedural Schedule

A planning conference was held on July 8, 2020. Douglas Law was present on behalf of Black Hills. Bill Austin, the Public Advocate, was present. Chris Dibbern was present on behalf of NMPP and ACE. IBEW was not present. Pursuant to the planning conference, a procedural schedule was set and is set forth below.

The schedule set forth in this order allows the Commission to enter a final order in this proceeding within 240 days from the date of filing. In constructing this schedule, the Commission is not making a final interpretation of the time period allowed under Neb. Rev. Stat. § 66-1838. The Commission adopts this timeframe only in recognition of the different possible interpretations of this statute.¹

A. Service

Parties may meet filing deadlines outlined herein by sending an electronic copy of the filing via electronic mail to psc.naturalgas@nebraska.gov, so long as all parties are served via electronic mail contemporaneously.

B. Discovery

All discovery responses are due within ten (10) days of service, unless otherwise agreed to by the Parties. Any discovery request served after 3:00 p.m. shall be considered filed the following day for purposes of calculating response time. Parties should reference the Nebraska Court Rules of Discovery in Civil Cases for general guidance as to the conduct of discovery. Should this order conflict with any provision of said Rules, this order controls. Parties should make efforts to resolve any discovery disputes.

All parties shall provide a courtesy copy of any discovery requests and responses to the Commission. Such discovery requests and responses shall not be part of the official record unless they are offered and accepted as exhibits during the hearing on the application. Courtesy copies should be sent to psc.naturalgas@nebraska.gov.
