BY THE HEARING OFFICER:

On March 5, 2024, the Commission opened this docket on its own motion in order to review the gas supply procurement practices associated with gas purchasing of NorthWestern Energy Public Service Corporation d/b/a NorthWestern Energy ("NorthWestern"),¹ Sioux Falls, South Dakota, pursuant to Neb. Rev. Stat. § 66-1854. The Commission previously conducted a financial review of the gas supply cost adjustment schedules filed by NorthWestern regarding the gas supply in Docket No. NG-115, however a management and prudency review of NorthWestern's procurement policies was not conducted at that time.² This sub docket was opened to conduct the second planned portion of the audit of NorthWestern, the management audit.

A petition for Formal Intervention by the Nebraska Public Advocate ("PA") was approved by the Commission on March 20, 2024. No other parties have intervened in this docket.

Procedural Schedule

On March 12, 2024, a planning conference was held with the parties to this docket for the purposes of establishing a timeline for the completion of the Commission's review. This order serves to formalize the timeline for proceedings in this docket.
