## BY THE HEARING OFFICER:

On March 5, 2024, the Commission opened this docket on its own motion in order to review the gas supply procurement practices associated with gas purchasing of NorthWestern Energy Public Service Corporation d/b/a NorthWestern Energy ("NorthWestern"), Sioux Falls, South Dakota, pursuant to Neb. Rev. Stat. § 66-1854. The Commission previously conducted a financial review of the gas supply cost adjustment schedules filed by NorthWestern regarding the gas supply in Docket No. NG-115, however a management and prudency review of NorthWestern's procurement policies was not conducted at that time.¹ This sub docket was opened to conduct the second planned portion of the audit of NorthWestern, the management audit.

Notice of the application was published in <a href="The Daily Record">The Daily Record</a> on March 7, 2024. A petition for Formal Intervention was filed by the Nebraska Public Advocate on March 19, 2024, and her intervention was approved by the Commission on March 20, 2024. No other parties have intervened in this docket. On April 30, 2024, the Commission entered a hearing officer order setting forth the procedural schedule, wherein it directed parties to file its responses, comments, and/or recommendations to the Commission's audit report by 5:00 p.m. on Monday, September 23, 2024.

On October 1, 2024, NorthWestern filed a motion for leave to submit a pre-filed statement after the September 23rd filing deadline. NorthWestern's pre-filed statement was attached to its
