BY THE COMMISSION:

On September 10, 2024, the Nebraska Public Service Commission ("Commission"), on its own motion, opened the above-captioned docket to amend Title 291, Chapter 8, Grain Warehouse and Grain Dealer Rules and Regulations and released the first set of proposed rules for public comment. Interested parties were instructed to file comments with the Commission on or before Friday, October 11, 2024. No comments were filed in this docket.

A public hearing on the proposed rules was held on November 7, 2024, in the Commission Hearing Room in Lincoln, Nebraska, and remotely via WebEx. Notice of the hearing was published in The Daily Record; the Omaha World-Herald; and the Lincoln Journal Star. Additional notice of the hearing was sent to the Chair of the Executive Board, the Governor's Policy and Research Office, and the Nebraska Secretary of State. Jonathan Smith, Legal Counsel, and Terri Fritz, Director of the Grain Department, appeared before the Commission to describe the proposed rule amendments. The Commission received no written comments and no parties offered testimony at the hearing.

Based upon the information in the record, the Commission is of the opinion and finds that the proposed rules attached hereto as Appendix A and incorporated herein by this reference should be adopted.
