O P I N I O N A N D F I N D I N G S

On September 10, 2024, the Nebraska Public Service Commission ("Commission"), on its own motion, opened the above-captioned docket to amend Title 291, Chapter 8, Grain Warehouse and Grain Dealer Rules and Regulations and released the first set of proposed rules for public comment.

Interested parties were instructed to file comments with the Commission on or before Friday, October 11, 2024. No comments were filed in this docket. On October 16, 2024, an Order was issued by the Commission setting a hearing to review the proposed rules for Thursday, November 7, 2024. Notice of the hearing was published in the Omaha World Herald on October 18, 2024, and in both The Daily Record and the Lincoln Journal Star on October 21, 2024. Additional notice of the hearing was sent to the Chair of the Executive Board, the Governor's Policy and Research Office, and the Nebraska Secretary of State. The scheduled hearing was held in the Commission hearing room at 10:00 a.m. Central Time on November 7, 2024. The Commission received no written comments, and no parties offered testimony at the hearing. As a result, the Commission issued a Certificate of Adoption for the proposed rules on December 3, 2024.

Since issuing the Certificate of Adoption, it has been brought to the attention of Commission Staff that the time between the date of publication of the notice of hearing and the date the hearing was held in this matter did not meet the statutory requirement of a 30-day period between the date of notice and the date of the hearing.¹


