BY THE HEARING OFFICER:

On June 6, 2024, NorthWestern Energy Public Service Corporation d/b/a NorthWestern Energy ("NorthWestern") of Sioux Falls, South Dakota, filed an application with the Nebraska Public Service Commission ("Commission") seeking approval of a natural gas general rate increase in Nebraska. The Application seeks to increase rates to customers located in Grand Island, Kearney, North Platte, and Alda.

In accordance with Neb. Rev. Stat. § 66-1838, Northwestern sought to negotiate the rate increase directly with the above-mentioned municipalities. The matter was certified for negotiations on August 6, 2024.

On April 29, 2025, Northwestern filed Notice of Settlement and a copy of the Settlement agreement reached with the above-listed municipalities. Pursuant to Neb. Rev. Stat. § 66-1838(14), "Any agreement filed with the commission shall be presumed in the public interest, and absent any clear evidence on the face of the agreement that it is contrary to the standards and provisions of the State Natural Gas Regulation Act, the agreement shall be approved by the commission within a reasonable time."

The Hearing Officer finds that hearing on the Agreement filed by Northwestern shall be set for **Wednesday, May 21, 2025, at 9:00 a.m. (CST)** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska. Webconference access will be made available to the parties.

The Commission's review is limited to the face of the agreement. Therefore, the hearing is intended only to afford Commissioners and Commission staff the opportunity to ask questions regarding the agreement. Any presentation or comments

will be received in the same manner as oral argument. The only evidence to be entered into the record will be the settlement agreement itself. Members of the public will be afforded an opportunity to comment, but will not be required to be placed under oath.
