BY THE HEARING OFFICER:

On May 1, 2025, Black Hills Nebraska Gas, LLC d/b/a Black Hills Energy ("Black Hills"), of Rapid City, South Dakota filed an application with the Nebraska Public Service Commission ("Commission") seeking approval of a general rate increase. On June 10, 2025, the Commission entered a hearing officer order setting the procedural schedule. This schedule included the announcement of town hall meetings, to be held during the week of August 18th. At the time of the scheduling order, the dates and times of the town hall meetings were undecided.
