BY THE COMMISSION:

Upon the verified Complaint of Terri Fritz, Director, Grain Warehouse and Dealer Departments of the Nebraska Public Service Commission ("Complainant"), filed on October 24, 2025, Hansen-Mueller Co. of Omaha, Nebraska ("Respondent") is alleged to be in violation of Neb. Rev. Stat § 75-903(2) and 291 Neb. Admin. Code § 8-003.09 for failing to make payments on demand.

Included in Complainant's requests for relief, Complainant seeks temporary suspension of Respondent's grain dealer license. Pursuant to Neb. Rev. Stat. § 75-903.01, if the Commission determines that the public good requires it, the Commission may, after the filing of a complaint and without hearing, temporarily suspend a grain dealer's license pending the determination of a complaint. The Complaint alleges that the Respondent has failed to compensate several Nebraska producers who have delivered grain to Respondent and demanded payment. Based on the allegations contained in the Complaint and the potential risk associated therewith, the Complainant seeks an Order Temporarily Suspending Respondent's grain dealer license.

Based on the severity of the allegations contained in the complaint, the Commission finds that the public good requires the license granted to Hansen-Mueller Co. in GD-2149 be temporarily suspended pending the determination of the Complaint filed in GDC-467.

IT IS FURTHER ORDERED that Hansen-Mueller Co. shall cease and desist any current and future grain dealer activity within the State of Nebraska
