**O P I N I O N   A N D   F I N D I N G S**

The Nebraska Public Service Commission (“Commission”) hereby opens the above-captioned Progression Order in this docket to determine the surcharge for the statewide Nebraska Telecommunications Universal Service Fund (“NUSF”) for the upcoming fiscal year. The Commission is charged under Neb. Rev. Stat. § 86-328 with the duty of holding a public hearing each year to determine the level of fund necessary to carry out the provisions of the Nebraska Telecommunications Universal Service Fund Act.

As required by § 86-328, the Commission will publish notice of this hearing in at least one newspaper of general circulation in the state for two consecutive weeks before the hearing. After this hearing, the Commission shall determine the necessary amount of the NUSF surcharge for the fiscal year beginning July 1, 2026.

Accordingly, the Commission sets this matter for public hearing on **Tuesday, May 12, 2026, at 11:00 a.m. Central Time** in the Commission Hearing Room, 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska. Videoconference attendance to the hearing will be available through the Commission’s website, available at <http://psc.nebraska.gov/stream>.
