

## **2025-2026 911 PSAP Annual Funding Application**

It is time to complete your Annual 911- PSAP Applications for the 2025-2026 funding year. Please find the annual application form on our website under the link below and the “PSAP Application for Annual Funding Form” drop-down box

### **Please read the following regarding the completion of your funding application:**

- If you have questions regarding the equipment type, model, or version of the software please contact your vendor. The questions on dates of installation, refresh, and next estimated update on the CPE **must be completed** on the application.
- On the questions regarding maintenance, please be specific. Do you have a maintenance/support contract and who is it with, or are you paying on a time and materials basis? Give the dates on contract.
- GIS – Please name the vendor for any third-party mapping software used in your PSAP, which is not part of your call handling or CAD solution, even if they are linked. Note that this may be different from your GIS Data Maintenance provider. Your MSAG Coordinator may also be different from your GIS vendor; be sure and check before filling out the application.

### **Documentation of Call Volume is no longer needed:**

- Call Volume will be figured using ECaTS data.

### **Submitting Application and Contracts:**

- Since you will be submitting your application and contracts by email, please make sure your documents are pdf or word docx/doc files.

- Please include a copy of any newly signed, (in 2024), maintenance/support agreements that you intend to use wireless funds to pay for.
- Unsigned applications will not be considered complete.

## New PSAP Annual Funding Application Form FY 2025-2026 Memo

With the implementation of NG911, ECaTS, and the new funding model, the PSC is still evolving and updating the PSAP annual application. This is the fourth year that the deadline of these completed applications is on **March 31**.

Even though PSAPs no longer need to submit call volume documentation with the application, please continue to submit copies of any newly signed maintenance/support contracts with the application.

Under the GIS section, if you have an in-house GIS person instead of a vendor, please provide their name and contact information. This person may be different than the MSAG Coordinator. Please provide the name of your MSAG Coordinator as well.

The PSC received better answers to the budget question on the application last year. The funding/budget question is to capture the necessary information so that the federal reporting requirements can be met. For example, one question that Nebraska needs to answer is: "*what is the total annual cost of operating 911 in the state of Nebraska?*"\_With each PSAP reporting what it costs them to operate their PSAP in the previous calendar year, we will be better able to answer this federally required question. Please use 2024 calendar year regardless of what your fiscal year is. Also, you may send budget sheets if you wish, but please fill out the application form that is where the numbers will be pulled from.

Questions on the application form will assist the PSC in providing more accurate information for the required federal reporting. Part of the federal reporting is certifying that no jurisdiction that has control over 911 surcharge fees has not diverted any of those monies for other than 911 purposes. By signing the application form, you are certifying that you have not diverted any 911 surcharge fee money.
