PSC Resolves Complaint Approves Remediation Plan for Windstream

The Nebraska Public Service Commission (PSC) has entered into a stipulated agreement with Windstream and dismissed the department complaint (911-078/DC-104/C-5596) against the telecommunications carrier concerning three separate 911 outages/disruptions.

Through the stipulated agreement approved by a unanimous vote of the Commission in October, Windstream will invest more than one million dollars into its network reliability and diversity. In the included 911 Remediation Plan, Windstream agreed, among other improvements to:

- Enhance its backup systems to address power outages.
- Provide an additional layer of reliability and protection against outages by adding a new network path. This third path has the capacity to carry all of Windstream's traffic in Nebraska should the other two paths go down and repairs need to be made.
- Engage a third-party auditor to complete a system reliability and engineering review of its Nebraska network.

The agreement also provides for civil penalties if Windstream does not complete the agreed upon enhancements and improvements by the end of 2025.

"Windstream has agreed to make more than a million dollars of improvements to its network," said State 911 Director Dave Sankey. "These improvements will positively impact public safety communications in Nebraska.,"

The stipulated agreement follows an investigation involving three separate Windstream service disruptions which occurred on September 2 & 3, November 28, 2023, and January 13, 2024. As part of its investigation the Commission conducted data requests, held a public hearing, and sought analysis from outside experts on network infrastructure specifically in the area of 911 network requirements. As a result of the investigation a complaint was filed by the State 911 department. The department complaint resulted in the stipulated agreement and the remediation plan approved by the Commission.

PSC Holds Hearing on Lumen 911 Investigations

In early November, the PSC held a hearing for telecommunications carrier Lumen, concerning three separate service outages/disruptions affecting 911. The three separate outage/disruptions occurred on August 31, 2023, April 17 & July 9, 2024, and impacted 911 service over a wide area of Lumen's network.

An initial hearing regarding the August 31, 2023, Lumen outage was held in January. As the Commission expanded its investigation to include the 2024 disruptions it conducted additional data requests and sought analysis from outside experts on network infrastructure specifically in the area of 911 network requirements < https://psc.nebraska.gov/lumen-affiliates-911-outage-investigation>.

Commissioners will now deliberate the testimony and information presented at the hearing before issuing an Order regarding the outcome and potential action regarding the investigations.

Pro-Ag Grant Application Released



Applications for the 2024-2025 Precision Agriculture Infrastructure Grant (PRO-AG) program are now being accepted. The process opened on December 13 with applications due on or before January 17, 2025, at 5:00 p.m. (CT).

With more than one million dollars in funding available, the PRO-AG program paves the way for awarding grants to accelerate rural economic development by helping to provide connectivity and supporting technology in rural areas of Nebraska.

The PRO-AG program is divided into two distinct subprogram; Connectivity and Devices and Technology with the available amount divided equally among the two subprogram. Application materials and a detailed program guide can be found on the <u>Precision Agriculture Infrastructure Program (PRO-AG)</u> page of the PSC website. Grants will be awarded by the end of April.

Tours Update Commission on Black Hills Energy Projects

Commissioners and staff were given a firsthand look by Black Hills Energy (BHE) of some of its current project sites. Several opportunities were provided by BHE for the PSC to visit the At-Risk Meter Relocation (ARMR) project and the Lincoln Town Border Station (TBS).

Through its ARMR project, BHE is relocating natural gas meters in certain Lincoln neighborhoods. In these neighborhoods natural gas meters are typically located inside a structure such as a basement or garage. The project consists of moving the meters outside the structure. Meter relocation from inside a structure to outside involves installing a new underground service line connecting to the natural gas main, which then brings service to a new meter at or near the structures.


As technology has advanced, industry standards now endorse relocating meters outside of a structure, mainly for safety reasons including accessibility in emergency situations. In addition to Lincoln, through its multi-year ARMR project BHE is also relocating meters in Neligh, McCook, and Gering.











Seal Fees Set for Housing/RV Department

Commissioners in October approved an Order setting the fees for the Manufactured Homes, Modular Homes, and Recreational Vehicle Programs for 2025.

Following its annual fee hearing, the Commission determined that the fees would remain the same for the upcoming year.

- Manufactured Homes (ManF-17) Seal Fee \$400
- Modular Homes (MODF-18) Seal Fee 19¢ per square foot, New Manufacturer plan approval \$1,800
- Recreational Vehicle (RVF-18) Seal Fee \$20 & plan review fees \$ 20.00

As part of its responsibilities site inspections are performed by PSC staff at the factory to assure the structures are built in accordance with the approved documents, adopted building codes and all applicable State statutes and regulations.

Commission Approves 911/988 Standards

The Nebraska Public Service Commission acting on the recommendation of the 911 Service System Advisory Committee (911SSAC) adopted statewide uniform standards that will allow Public Safety Answering Points (PSAPs) on the 911 service system to communicate, coordinate, and enage with the 988 Suicide Crisis Lifeline (988).

Required by state statue (Neb. Rev. Stat. §86-1025), the uniform standards were developed over several months through the hard work of an ad-hoc 911SSAC working group, in conjunction with the Department of Health and Human Services, representatives of Boys Town and the University of Nebraska Public Policy Center

The standards provide for the ability of a PSAP to transfer a caller with permission to the 988 Suicide & Crisis Lifeline and the ability for 988 to transfer calls to a PSAP. The standard also recommends that PSAP telecommunicators have training suitable for carrying out their ability to transfer calls and receive calls from 988.
