THE FEDERAL EXECUTIVE AGENCIES' MOTION TO WITHDRAW

The Federal Executive Agencies (“FEA”), by and through its attorneys, Aleta S. Kretzer, Leslie R. Newton, Ashley N. George, Michael A. Rivera, and Thomas A. Jernigan, moves the Commission for an Order withdrawing itself from the proceedings as a formal intervenor and protester in the above captioned matter and relinquishing the FEA’s status as a party to the proceedings.

On May 30, 2025, FEA submitted its Petition for Formal Intervention and Protest citing potential significant impact on our military installations and federal facilities that take service from Black Hills Nebraska Gas, LLC d/b/a Black Hills Energy (“BHE”). However, after further impact analysis, FEA has determined it is not cost effective to continue our intervention in this matter at this time.

WHEREFORE, FEA respectfully seeks the Commission’s Order accepting this withdrawal from this docket and terminating FEA’s status as a party to the proceedings.
