To Whom it May Concern:

This letter is to express our support for Glenwood Telecommunications, Inc.'s application to the Nebraska Broadband Bridge Program.

Glenwood, together with Fillmore County, has been fortunate to secure NBBP funding in two previous instances. As a result, more than 100 (previously unserved) homes and businesses in our rural areas now have access to dependable, high-speed broadband.

Glenwood's application for the 2024 Nebraska Broadband Bridge Program identifies 83 designated unserved households in the rural area of Fillmore County, currently lacking sufficient broadband connectivity. This inadequacy in internet service results in local students being deprived of essential educational resources, limits telehealth options for families, impedes remote work opportunities and prevents our farmers from adopting advanced agriculture technology.

I am writing in support of Glenwood's application for the Nebraska Broadband Bridge Program in Fillmore County. As you know, being connected in today's world is essential. Money spent on fiber infrastructure will ensure we can continue to do business in rural parts of Fillmore County in the future.

Currently at our farm we rely on wireless internet connections that are hit or miss at best and not very fast when they do work. Wired connections are not available in our area. In order to have internet service working 100% of the time in our farm office and also in my cousin's house, who lives at the farm, we have to have internet service subscriptions to two different companies in hopes that one of them will always be working. The speeds of these services though do not match our needs for a modern farming operation. Currently it takes several hours to upload the data from our tractors, implements, and combines into the cloud from our farm internet service at less than 10mbps. These services are not reliable and tend to go down several times a week. I am constantly switching internet sources on my computer to find the one that is working that day. Glenwood has been a great partner in Fillmore County. Since the fiber buildout in Shickley, I have not lost service since Glenwood installed their service to my house. It has been a gamechanger for getting work done at my home.

I have been working with Glenwood for the past 4 years, starting with the project in the Village of Shickley and afterwords trying to get them to come to our farm with fiber service. They were timely, very professional, and great to work with when completing the project in Shickley. The first round they were 2 miles east and now with the 2024 round they are 1.5 miles south of our farm. We have been surrounded by fiber but have not had the ability to connect to it ourselves. Glenwood informed me the other day that our farm would be included in the next round of buildout. That would greatly help our ability to do business from our farm office and across our fields with connected devices in the field.

The Nebraska Public Service Commission's investment in the fiber service to our homes and businesses is today's equivalent of the REA bringing electricity to rural Nebraska. You all have the ability to make it financially feasible to bring once in a lifetime infrastructure upgrades that will benefit us for many years to come here in rural Fillmore County.

Without securing this grant, Glenwood has told me that it is not financially feasible to continue the fiber buildout and reach our farm. Just to build from their existing lines to our farm would cost approximately \$40,000. A figure that no one resident can afford to bring reliable internet to their premises without this grant funding.

I strongly support Glenwood and the work they are doing to bring fiber to south central Nebraska communities. The work they are doing is lifechanging for so many of us here in rural Nebraska where the incumbent telecommunications carriers invest very little in our infrastructure. Those providers, if they do answer a call, never respond to fix or upgrade services in our area. Glenwood is a shining star for investing in rural Nebraska for those of us with few options to connect. I fully support the work of Glenwood on their Fillmore County Fiber Project and I hope the Commission continues to fund these projects for Glenwood until every resident and business can access fiber internet services.
