CORONAVIRUS CHANGES 911 SSAC MEETINGS

The coronavirus responsible for the COVID-19 pandemic led to new ways of doing business for just about every facet of our daily lives.

For the 911 Service System Advisory Committee (911 SSAC) that meant holding meetings virtually. Committee members and those in the public wishing to attend did so through [WebEx](#).

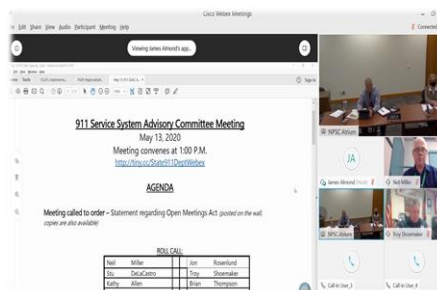
“Despite the change to a virtual environment, we had good participation and managed to move forward with some key recommendations,” said David Sankey, State 911 Director. “

During the board’s April 1 meeting, members recommended a new funding mechanism for NG911. The recommendations were then sent to PSC Commissioners for their approval. On May 5, Commissioners issued an [Order](#) opening a docket and seeking public comment on the recommendations.

“Moving forward with approval of a funding mechanism is a key factor toward the implementation of NG911 in Nebraska,” *State 911 Director, David Sankey.*

The public comment period on the proposed funding recommendations ended June 5. Commissioners and PSC staff will now review the comments to help refine the proposal. A public hearing on the funding recommendations will take place at a later date before a final vote by the Commission is held.

The committee also held a virtual meeting May 13, with members providing [working group updates](#). The next 911 SSAC meeting will be held July 15, at 1:00 pm, with the location for the meeting to be set at a later date.

I appreciate your willingness to continue to be committed and remain engaged during this time and look forward to the day when we will once again be able to conduct business as usual.

Proclamation Recognizes Public Safety Telecommunicators Week

In a year when nothing is as it was, we still managed to get Governor Ricketts to sign a Proclamation recognizing April 12-18 as National Public Safety Telecommunicators Week in Nebraska.

With no public proclamation signings held due to the COVID-19 pandemic the proclamation honoring our dedicated, hard-working public safety telecommunicators/dispatchers, was signed and put in the mail.

The proclamation once received was posted on PSC social media. The Commission will once again provide a signed copy of the proclamation to PSAPs for display.

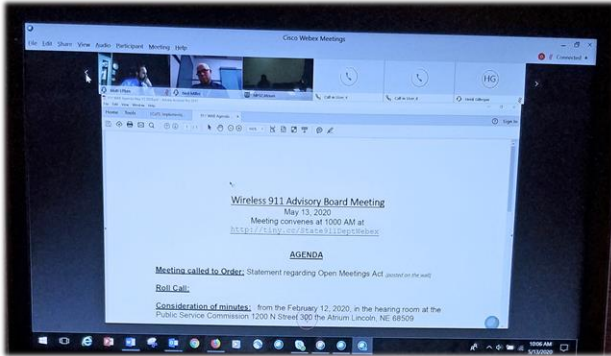


WIRELESS 911 ADVISORY BOARD HOLDS VIRTUAL MEETING

The Wireless 911 Advisory Board meeting held its' May 13 meeting in a virtual environment due to gathering restrictions related to the COVID-19 pandemic.

The meeting was called to order by Chair Steve Reeves of North Platte. State 911 Director David Sankey provided an update on ECATS and talked about two recent Orders related to 911, approved by the PSC.

The board then approved funding order for several cities and counties. Before adjourning, the next board meeting was set for Wednesday, August 19. A location for the meeting will be set at a later date.

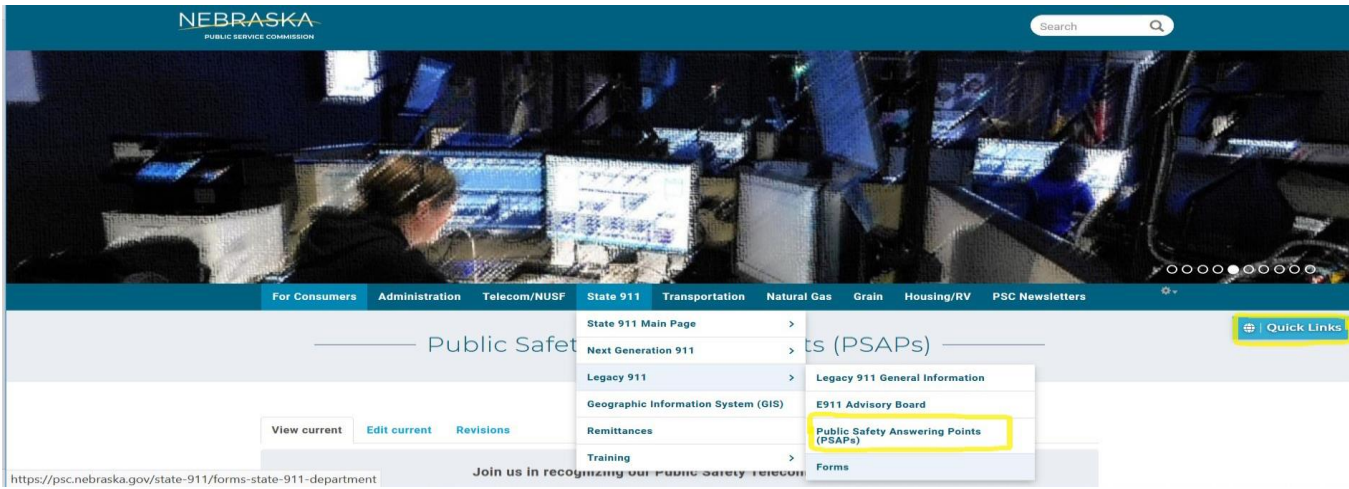
Audit Information Provided
