The Green Forward program became available for customer enrollment in January 2023. The Green Forward program provides Nebraska customers the opportunity to purchase carbon offsets from projects that reduce or prevent the release of greenhouse.

Mid-Year Green Forward Program – Report – Through June 30, 2024

On December 13, 2022, the Nebraska Public Service Commission approved Black Hills Nebraska Gas, LLC d/b/a Black Hills Energy (“Black Hills” or “Company”) Green Forward program (Order Approving the Application, Docket No. NG-117). The Green Forward program was launched in January 2023 and first marketed to Nebraska customers starting in May 2023.

The Green Forward program attrition during the first two years of implementation has been below the modeled 8% year one attrition rate and the 14% year two and beyond rate. Since launching in 2023, 8 customers have unenrolled from the program in Nebraska, an attrition rate of less than 5 percent. Attrition will continue to be monitored and if it exceeds the projected rates, Black Hills will deploy an anonymous survey to prior participants who still have utility service once annually for feedback on their decision to leave the program.

2. Comparisons of Nebraska to Other Black Hills Jurisdictions

The Green Forward program is operational in all Black Hills Energy natural gas states. The program has been approved as a regulated offering to customers in Arkansas, Kansas, Nebraska, and Wyoming. The program operates as a non-regulated offering in Colorado and Iowa.

The Green Forward program and product content label is identical in each of the natural gas jurisdictions in which it operates. The block prices, ratio of RNG thermal certificates to Carbon Offset Credits, and general terms of service for the Green Forward program are the same. The one program structure exception is Arkansas, where Black Hills bills in CCF. The emissions addressed have been converted from therms to that unit of measure (CCF) for customer convenience when considering participation and deciding level of participation.

3. Deferred Accounting Balance and Cost Allocation Methodologies

As described in the Green Forward application, Black Hills allocates costs based on the number of customers located within the different states and based on the number of approved service areas when expenses are incurred. However, direct expenses attributable to a specific state will be charged directly to that state’s program. Other common costs will be allocated between the states where the Green Forward program is operational.

Costs and revenues for the Green Forward program in Colorado and Iowa (non-regulated model) will be invoiced separately and accounted for separately from regulated programs with approved deferred accounting treatment (Arkansas, Kansas, Nebraska, and Wyoming).

*Financial Comparison to last Green Forward program Report:

In the Report dated February 20, 2024, financial costs associated with launching marketing were still in progress and all expenses had not yet been incurred. That work is now completed and cost a total of \$141,468.21. A one-time adjustment will be made to the Green Forward account allocating the launch marketing costs to all participating jurisdictions. The allocations for CO and IA programs, totaling \$46,847.71, are moved out of this account and to the non-regulated program accounts for those jurisdictions. After this one-time adjustment, the NE 2023-2024 Cumulative Program Balance is (\$88,559.70) compared to (\$120,249.65) in the previous Report.

4. GREEN-e® Compliance Status

Green-e® climate certification is on track for achievement in 2025. The program adheres to the requirements for Green-e® certification across all jurisdictions. Marketing, customer communications, internal communications, and required reporting have now been deployed within guidelines of the Green-e® Climate program, a global third-party certification program for carbon offset credits. Black Hills will apply for certification in Q2 of 2025. The Green Forward program will have been fully launched in all states, and we will complete the supply purchase for all states at that time. Once the supply is procured and retired on behalf of participants across all jurisdictions, 3Degrees will provide data and documentation for the certification process. All aspects of compliance requirements for Green-e® Climate certification have been incorporated into the Green Forward program in anticipation of achieving this compliance certification for participants in 2025.

5. Marketing and Communications Plan Status

Black Hills Energy opened enrollment into the Green Forward program in January 2023. Black Hills Energy developed marketing materials and began marketing the Green Forward program in May 2023 through advertising, email, direct mail, and social media channels. The table below is the 2024 Plan and describes the number of customer contacts that were attempted (email / direct mail) and achieved (digital / social) for the purposes of customer education and program marketing.

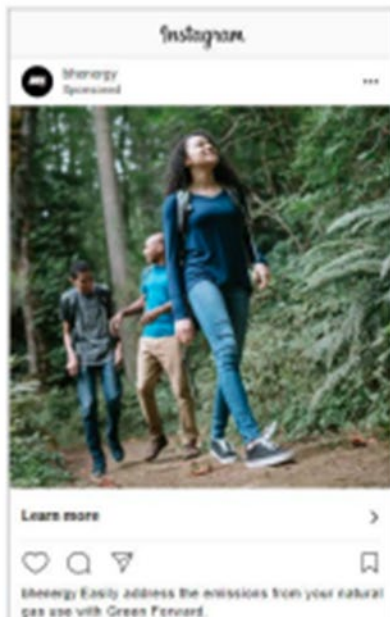
