Nebraska Specialized Telecommunications Equipment Program (NSTEP)



WHAT THIS PROGRAM DOES.

Provides financial assistance to help Nebraskans with hearing, vision-and hearing, or speech disabilities obtain specialized telecommunications equipment.

WHAT YOU CAN GET.

- Amplified or captioned phones
- TTYs
- Signaling devices
- Wireless devices (with participating providers)
- Other approved telecom equipment

ELIGIBILITY

You may qualify if:

- You have a certified disability affecting telephone use
- You are 3+ years old
- You live in Nebraska
- You have or have applied for phone service
- You haven't received program equipment in the last 3 years

EQUIPMENT OWNERSHIP

You own the equipment once purchased.

WHO CAN APPLY

- Deaf
- Hard of Hearing
- Deaf-Blind
- Blind/Low Vision with Hearing Loss
- Speech Disabled

**A qualified professional must certify the disability.*

HOW THE PROGRAM WORKS

- Apply online or through PSC or NCDHH
- Receive a voucher
- Select equipment from approved vendors
- Optional setup and training available
