By signing and submitting this application, the applicant hereby agrees to the following terms and conditions:

- a. Within the first twenty-five (25) seconds of the call clearly state the identity of the person making the call.
  - Our rules define person as “any individual, firm, organization, corporation, company, association, partnership, joint stock association, body politic, common carrier, society, legal representative, trustee, receiver, assignee, guardian, executor, or administrator”.

- b. During or after the message, clearly state the telephone number, other than that of the device which made the call, or address of the person. Address shall include street address, website address, or email address;
- c. Script filings shall include the permit number of the automatic dialing-announcing device transmitting the script, the date the script first began to be transmitted, and an electronic audio file that indicates the run time of the message;
- d. For Registration Applicants: to file scripts of any messages not already on file with the Commission within 24 hours of beginning to transmit the message;
- e. For Permit Applicants: to file scripts of any messages not already on file with the Commission within five (5) days of beginning to transmit the message;
- f. To notify the Commission of any changes of the information contained in this application within five (5) days of the change;
- g. To only transmit calls between the hours of 8:00 a.m. to 9:00 p.m., Monday through Saturday, and between the hours of 1:00 p.m. to 9 p.m. on Sundays and legal holidays. All times are determined by the local time of the called party;
- h. To disconnect the automatic dialing-announcing device from the telephone line of the person called within five (5) seconds of the time notification is transmitted to the device that the person has hung up, or as soon as the telephone company's central office equipment permits;
- i. To prevent such a device from calling emergency telephone numbers of police or fire stations or medical or other facilities providing emergency services as designated by the Nebraska Public Service Commission;
- j. To operate an automatic dialing-announcing device only in such a manner as to allow it to dial telephone numbers randomly; and
- k. To follow and abide by all other rules and regulations of the Nebraska Public Service Commission regarding the use of a device in Nebraska.
