Speed Delivery Documentation

Included in this Attachment C is NCTC's most recent FCC Form 477 filing. As of June 30, 2022, NCTC delivered speeds of 100/100 Mbps or greater to 19 subscribers. However, NCTC does have the ability to deliver those speeds to significantly more customers and anticipates more subscribers will take advantage of those speeds moving forward.
