**Speed delivery documentation**

Included in this Attachment are the most recent FCC Form 477 filings for both Nebraska Central Telephone Company (NCTC) and Hamilton Telecommunications (Hamilton)<sup>1</sup>. As of the June 30, 2021 filing date, NCTC delivered speeds of 100/100 Mbps or higher to five subscribers. However, NCTC does have the ability to deliver those speeds to significantly more customers and anticipates more subscribers will take advantage of those speeds moving forward.

Like NCTC, Hamilton also currently delivers speeds of 100/100 Mbps or greater to customers. Hamilton's most recent FCC Form 477 filing demonstrates that as of June 30, 2021, Hamilton was delivering speeds of 100/100 Mbps or greater to 570 customers. Hamilton is excited to use the expertise it has gained in both building its broadband network and procuring subscribers in higher speed tiers during the construction of NCTC's fiber network.
