**Speed delivery documentation**

Included in this Attachment are the most recent FCC Form 477 filings for both NCTC and Hamilton Telecommunications (Hamilton)<sup>1</sup>. As of the December 31, 2021, filing date, NCTC delivered speeds of 100/100 Mbps or greater to nine subscribers. However, NCTC does have the ability to deliver those speeds to significantly more customers and anticipates more subscribers will take advantage of those speeds moving forward.

Like NCTC, Hamilton also currently delivers speeds of 100/100 Mbps or greater to customers. Hamilton's most recent FCC Form 477 filing demonstrates that as of December 31, 2021, Hamilton was delivering speeds of 100/100 Mbps or greater to 273 customers. Hamilton is excited to use the expertise it has gained in both building its broadband network and procuring subscribers in higher speed tiers during the construction of NCTC's fiber network.

In addition to delivering 100/100 Mbps service to customers, NCTC clearly advertises that offering on their public facing website. The relevant portion of NCTC's website that advertises the available 100/100 Mbps speed tier is included in this Attachment.
