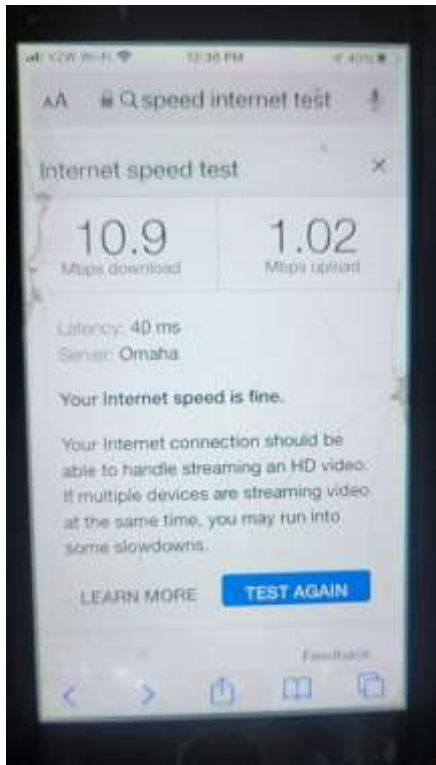


Northeast Nebraska Telephone Company - Polk County - Attachment Letter M
