



AFFIDAVIT OF JAMES P. WHITE FOR ADMISSION *PRO HAC VICE*

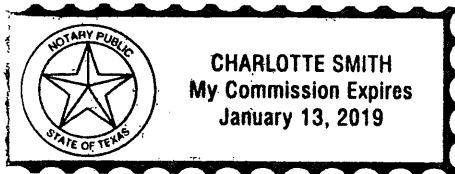
I, James P. White, desiring admission *pro hac vice* in the above-stated matter, affirms as follows:




