### BY THE HEARING OFFICER:

On September 7, 2021, the Nebraska Public Service Commission ("Commission") opened the above-captioned docket to address an application filed by NorthWestern Energy, Sioux Falls, South Dakota ("NorthWestern") to modify its tariff. The proposed modification relates to costs incurred by customers electing to convert from retail service to transportation service subsequent to the February cold weather event. A Petition for Formal Intervention was filed by the Nebraska Public Advocate on September 14, 2021 and was subsequently granted by order of the Hearing Officer on September 15, 2021.

# Procedural Schedule

After the submission of the application by NorthWestern, a planning conference was held with the parties to this docket. This order serves to formalize the timeline for proceedings in this docket.
