## LEGAL NOTICE NON-REGULATED NATURAL GAS DELIVERY CHARGE INCREASE

Black Hills Nebraska Gas Company, LLC d/b/a Black Hills Energy (Black Hills Energy) provides public notice pursuant to the State Natural Gas Regulation Act, Neb. Rev. Stat. § 66-1810(2), that effective October 1, 2023, Black Hills Energy will increase the customer charge for its non-regulated Agricultural and Interruptible natural gas services. Black Hills Energy's Residential and Commercial customers subject to the jurisdiction of the Nebraska Public Service Commission are NOT affected by this notice or applicable price increase. In addition, Choice Gas Program Agricultural and Residential/Commercial Customers in Rate Area 5 are NOT affected by this notice or applicable price increase.

notice or applicable price increase. The change in Black Hills Energy's natural gas customer charges apply to existing customers obtaining agricultural and interruptible natural gas services in and around Black Hills Energy's Rate Areas 1, 2, and 3, and to new Black Hills Energy customers who qualify for these services. Black Hills Energy will send a notification letter to each customer affected by this notice.

Agricultural Class Charges: On and after October 1, 2023, Black Hills Energy's nonregulated agricultural service customer charge will increase from \$29 per month to \$32 per month. The current base rate (delivery charge) of \$ 0.135 per therm for natural gas will also increase to \$0.150 per therm.

Internet to be take (denvery charge) of \$ 0.135 per therm for natural gas will also increase to \$0.150 per therm. Interruptible Class Charges: On and after October 1, 2023, Black Hills Energy's nonregulated interruptible sales and interruptible transportation services customer charge will increase from \$110.00 per month to \$120.00 per month. The current base rate (delivery charge) of \$0.135 per therm will also increase to \$0.150 per therm.

to \$0.150 per therm. Black Hills Energy provides regulated and non-regulated gas service to approximately 300,000 customers in Nebraska. The changes in this notice affect approximately 200 customers in Black Hills Energy's non-regulated Apricultural and Interruptible classes.
