Dear Mr. Golden:

Pursuant to Section 66-1808 of the State Natural Gas Regulation Act, Black Hills Nebraska Gas, LLC d/b/a Black Hills Energy ("BHE" or the "Company") herewith submits for filing with the Nebraska Public Service Commission ("Commission") the original and one paper copy of the following tariff sheet:

Eighth Revised Sheet No. 78  
Canceling Seventh Revised Sheet No. 78

By this filing, BHE is proposing to adjust the Customer Charges applicable to Residential and Commercial customers in Rate Areas 1-3 and 5.

This filing reflects changes in the overall Customer Charges of \$0.25 per month to cover the costs of BHE's HEAT (High Efficiency Assistance Tool) Program. The new HEAT Charge that BHE is proposing in this filing is an increase from \$0.14 to \$0.25 per month for Rate Areas 1-3 and 5.

The tariff sheet included with this filing bears a proposed effective date of January 1, 2023. Also included, as Exhibit C, is the Annual Report required by Sheet No. 132 of the Company's Nebraska Gas Tariff. The HEAT Program originally was approved by the Commission by its Order Approving Stipulation entered on December 27, 2006, in Commission Docket No. NG-0036. Pursuant to the approved Stipulation, and also by the Commission's Order Granting Application in Part entered on March 9, 2010, in Commission Docket No. NG-0060, the Company recovers, through its rates, the cost of rebates for space and water heating appliances issued through the HEAT Program via the HEAT Charge which is added to the monthly Customer Charge pursuant to Sheet No. 132 of BHE's Nebraska Gas Tariff. Pursuant to the Commission's Order Granting Application in Part entered on May 22, 2012, in Commission Docket No. NG-0067, the determination of the HEAT Charge now includes a reconciliation of HEAT Program costs and revenue collections, to ensure that costs are collected on a dollar for dollar basis under the HEAT Program.

Sheet No. 132 of BH's Nebraska Gas Tariff establishes the various terms of the Customer Retention Incentive Program, including the manner in which the monthly HEAT Charge is calculated. The above-referenced HEAT Charge of \$0.25 per month was calculated pursuant to the requirements of Sheet No. 132.
