AFTER DUE INVESTIGATION, it is hereby certified that the above-named carrier has complied with all applicable provisions of Neb. Rev. SUPPLEMENT 2: Transportation of passengers by bus in charter service between all points in Nebraska over irregular routes. HHS Designation: No.

SUPPLEMENT 3: Transportation of passengers by limousine between points in Sioux, Scotts Bluff, Banner, Kimball, Dawes, Box Butte, Morrill, Cheyenne, Sheridan, Garden, Deuel, Cherry, Grant, Hooker, Thomas, Arthur, McPherson, Logan, Keith, Perkins, Lincoln, Chase, Frontier, Dundy, Hitchcock, Red Willow, Blaine, Loup, Custer, Dawson, Buffalo, Gosper, Phelps, Kearney, Furnas, Harlan, Franklin, Sherman, Valley, Garfield, Holt, Rock, and Brown counties, and between said counties, over irregular routes.
