## Attachment F – Rate Comparability Details

In the Project Area, Charter will employ our nationwide pricing structure (called Spectrum Pricing & Packaging), which offers standardized pricing for each speed tier of broadband internet service Charter offers new customers across our 41-state service territory. Charter's pricing strategy ensures that rural customers receive the same pricing as other highly competitive areas in the state and country. Charter's wireline broadband offerings currently include no data caps, usage-based pricing, early termination or modem fees, long-term contracts, or metered "pay-as-you-go" service.

Current prices for Charter's Spectrum Internet Assist, Spectrum Internet, Spectrum Internet Ultra and Spectrum Internet Gig service tiers are as follows:

## **Future-Proofing:**

Charter's network is future-proofed to meet growing customer needs for years to come. Recognizing the importance of fast, reliable service for all customers, Charter's network is already capable of achieving up to 100 Gbps symmetrical speeds for large businesses, schools, libraries, hospitals, and other important community institutions through customized dedicated builds by our Spectrum Enterprise business organization. The present application and proposed budget do not include the costs of such customized builds. But Charter's network presence in the project area would better position the company to make such offers available.

## i. Low-Cost Programs

As described below, Charter has engaged in several initiatives and established numerous business practices that benefit consumers in need and demonstrate our commitment to the community. Charter has established several programs to provide low-cost internet service, particularly for students and remote learning, and has assisted customers struggling to pay their bills for service. Charter has supported communities by providing good paying jobs and long-term careers, and strengthening local organizations.

If awarded this grant, Charter agrees to commit to Participate in the Federal Communications Commission's (FCC) Affordable Connectivity Program (ACP); or otherwise provide access to a broad-based affordability program to low-income consumers in the proposed service area of the broadband project that provides benefits to households commensurate with those provided under the ACP. Charter will participate in or provide access to these programs through the life of the ACP.

• Affordable Connectivity Program: To further assist in closing the Digital Divide, Charter is participating in the \$14.2 billion federal Affordable Connectivity Program ("ACP") to help connect eligible households with high-speed internet. Broadband internet access is more important than ever. The ACP offers a tremendous opportunity to help low-income families stay connected, providing eligible households a discount of up to \$30 per month and up to \$75 per month for households on Tribal lands. The ACP credit is currently available to offset the cost of any of our broadband products for qualifying customers. Charter also offers Spectrum Internet 100, a high-speed, low-cost broadband service with 100 Mbps download speeds available to households qualifying for ACP. Eligible new households can get Spectrum Internet 100 for just \$29.99 per month, which includes a modem at no additional charge. The Spectrum Internet 100 promotional price (including WiFi) of \$29.99/month shall apply for 2 years; rate will increase

\$10/year until reaching standard \$59.99 rate in year 5. Because ACP provides qualifying households up to a \$30 monthly credit (\$75 on qualifying Tribal lands) toward broadband service, eligible customers can receive Spectrum Internet 100 at no monthly cost. • Spectrum Internet Assist: Charter also offers a low-cost broadband service to low-income students and seniors through our Spectrum Internet Assist (SIA) program. SIA provides high-speed broadband at a rate of \$24.99 per month (plus \$5 per month for Wi-Fi service) to qualifying households. SIA is available to qualifying households of which at least one member is a recipient of assistance under one of the following programs: National School Lunch Program (NSLP); Community Eligibility Provision (CEP) of the NSLP; Supplemental Security Income (for applicants age 65+ only). As to pricing, Charter cannot reliably predict — over the roughly seven-year time frame consisting of the Commission's evaluation period, the 18-month construction period, and the five-year commitment thereafter — market factors such as inflation, labor prices, equipment costs, legal and regulatory costs, technology changes, consumer preferences, and other important factors. Our product mix may also change. For example, just two years ago our lowest-speed standard offering was 200 Mbps, but we increased speeds to 300 Mbps in 2022. We plan to continue upgrading speeds and network capacity for all our customers in the future, such that comparing prices over time may be difficult.

Charter plans to meet the rate comparability and stability objectives of the CPF-1 program by:

- (a) Customers in the Project Area paying the same non-promotional rates that customers in Nebraska (outside the Project Area) pay, and
- (b) Providing this good-faith estimate<sup>6</sup> that our broadband prices (for the same speed tiers, if available) will not increase more than 5% on an annualized basis averaged over the five years following completion of the Project. (Note: we may not change prices on a regular, annual schedule, such that specific price increases may differ from our annualized, average estimates).
