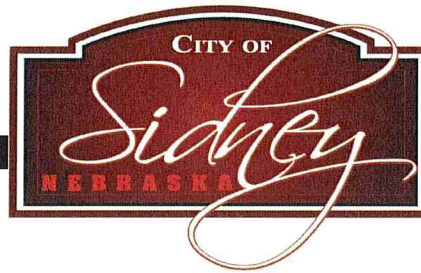
We are seeking feedback from Sidney leadership regarding the proposed project. We are excited about the opportunity to expand ALLO's current broadband network.
