"I think masks are something to think about," Dr. Brett-Major said. "We should be thinking about whether or not we have respiratory symptoms. We should be thinking about

whether or not we're sick, and we should be thinking about whether, if we're sick, we ought to be around others, whether that's school or otherwise. So, I think masks are something to think about. They are a tool for civility, and they are a tool for practical safety."

Ash Hollow SHP Visitor Center, Cave Temporarily Closed

The visitor center and cave at Ash Hollow State Historical Park are closed through Oct. 1 due to a staffing shortage. They will reopen at 10 a.m. Oct. 2.

The grounds of the historical park will remain open for visitors to enjoy hiking, picnicking, wildlife watching and other activities.

Ash Hollow's fall hours of operation for the visitor center and cave are Wednesday-Sunday, 10 a.m.-4 p.m. They will close for the season Nov.

As schools have returned to session and park staffing levels have become more limited, park managers have made adjustments to hours of operation and services as needed. The Nebraska Game and Parks Commission encourages its patrons to call ahead before visiting a park to check on activity times and availability to ensure a great park experience.

had to extract the driver from the vehicle, after which, they transported the driver to BBGH. The driver was later released.

Stephen noted that seatbelts were in use at the time of the accident and that no improper driving was suspected. He believes the vehicle sustained enough damage to be totaled.

The name of the driver was not released by the Box Butte County Sheriff's Office.

Stephen "Steve" William Waldron, 80, passed away Friday, September 24, 2021, at Regional West Medical Center in Scottsbluff, with his family by his side.

Steve was born on May 14, 1941, to William "Bill" and Genevieve (LaClair) Waldron, in Alliance. He was the second child of four. He graduated from Alliance High School in 1960, where he was a standout athlete, participating in football, basketball, and track. On April 14, 1961, he was united in marriage to Sandra Sue Steffen, his high school sweetheart. Keystone pipeline opponents hail end to eminent domain effort

Opponents of the now-scuttled Keystone XL pipeline hailed an agreement between a Canadian company and Nebraska landowners to terminate the company's efforts to condemn their land.

On Monday, a Madison County District Court judge accepted an agreement between TC Energy Corp and the Johnson and Herrick families to rescind condemnation proceed-

ings.

In June, TC Energy Corp., formerly TransCanada, said it was ending its decades-long effort to build a crude oil pipeline from Alberta to Nebraska. From there, the pipeline would connect to a system that reached the Gulf Coast. The company announced its decision after President Joe Biden in January revoked a necessary permit.

Jane Kleeb, founder

of Bold Nebraska, credited the work of everyday Nebraskans with stopping the pipeline.

"Land justice happened only because of the hard work of citizens, grassroots organizing, and a legal team who believed the land was worth protecting," she said.

Mark Hefflinger, also with Bold Nebraska, said about 60 landowners were in a situation similar to the Herrick and Johnson families.

He said pipeline opponents hope that TC Energy will reach similar agreements with the other families.

Additionally, pipeline opponents want to see easements granted to TC Energy be revoked so that they can't be transferred to another company.

TC Energy declined to comment on how

it would handle additional terminations of condemnation proceedings or any cancellation of voluntary easements.

"It would be inappropriate to speak to matters before the courts," the company said in a written statement. It did note that the project has been canceled.

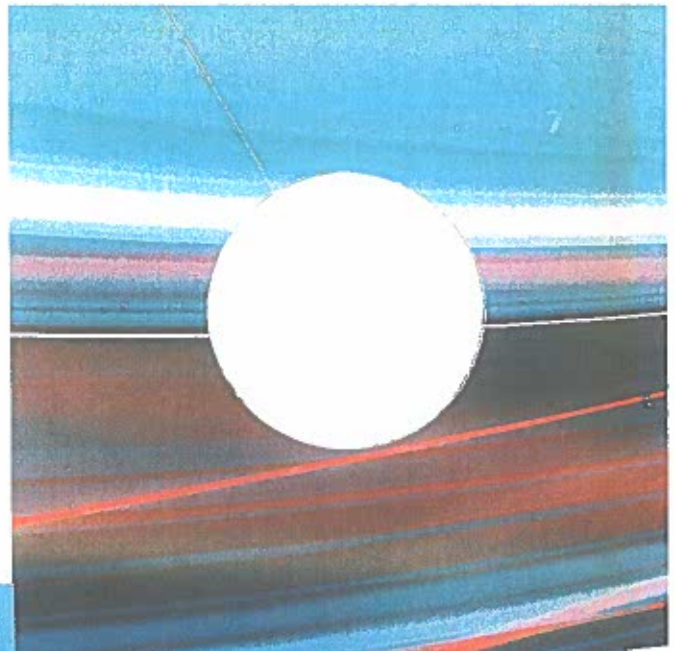
