

I am grateful to have been given the opportunity to submit a letter of support for the availability of fiber broadband for rural residents. Living in a rural area is truly a blessing but does have limitations in accessing fast and reliable internet service.

Ranching is an important part of my life but I am also employed by Chadron Community Hospital as the Director of the public/community health programs of Western Community Health Resources. With the responsibilities as the manager of multiple state and federal programs it becomes essential that I have access to internet service for completion of my duties. The COVID pandemic has expanded the need for working from home and I do not see that trend changing. On average I attend some type of interaction/meeting that includes Zoom, Webex, Teams, etc two to four times daily and complete three fourths of my daily activities with internet assistance. This option/opportunity has proven to be cost effective and employer friendly which solitifies the need for future sustainable reliable internet.

The ranching business not only includes regular communication utilizing internet but camera systems that are essential for monitoring and care of livestock. When weather is an issue I want to have the assurance of access and this proposal would help do that.

I thank you in advance for considering and prioritizing this proposal for broadband services for rural and remote areas and supporting those who live, work and play here.

Dear Grant Committee:

I am writing to voice my argument for the need of fiber optics in the very rural areas of the Nebraska panhandle.

I am viewing this need from many different perspectives. The first is as a small business owner. Our family owns and operates a world class horseshoeing school on our property that attracts students from every continent. When they attend, they need access to a stable internet connection to complete homework assignments and to stay in touch with family members. Often because of distance, the internet is the only way they are able to contact their loved ones. We have different housing options available, but are currently unable to provide dedicated internet service to that building because it isn't used consistently and we don't want to pay for something regularly that is only being utilized off and on. I understand that with the fiber optic internet wiring, it is possible to "hold" the service to specific parts of our plan. Currently, students using our 2nd housing option piggyback off of the signal to our home, which is next door. This makes it difficult for any internet use in our home, particularly for our 5 children (one who is homeschooling at this time) to complete schoolwork and homework assignments as well as other classes and enrichment activities such as Driver's Ed, that is offered online due to distance in our area to attend classes. On weekends, when our family wants to relax and stream a movie together, we often end up frustrated when students using our connection (which is a priority for our business) interferes with that particular activity we'd like to do. In our main facility, students often compete with the office for internet usage during business hours, which slows learning and productivity. Having a fast, reliable connection, particularly when we have full classes, would be a huge benefit to our students and our business.

In addition, I am a K-12 Visual Art Educator in our local rural school district. During quarantine, being able to be online and teaching during the entire school day was often thwarted and was very difficult having my own 5 children trying to participate in their own virtual classes. We often had to pick and choose, and scheduling my job vs. my children's education was a headache as a result.

Why should rural areas be any different in need than urban areas? We choose to live in these areas and we choose the agriculture lifestyle to benefit others globally whether we are raising crops and livestock to feed the world or giving students access to skills that benefit those ag producers as well as citizens around the world who use animals as a legitimate form of therapy, athletics and entertainment

Please consider our need for faster, more reliable internet in the less populated, but no less important, areas of the Nebraska Panhandle.


