Pursuant to Sections 66-1808 and 66-1854 of the State Natural Gas Regulation Act of Nebraska (Neb. Rev. Stats. §§ 66-1801 et seq.), and the Commission's September 9, 2003 Order in Commission Application No. NG-004, Black Hills Nebraska Gas, LLC d/b/a Black Hills Energy, submits the Seventeenth Revised Sheet No. 95, which details the factors in the Gas Cost Adjustment for each of Black Hills Energy's Rate Areas One, Two, and Three.

The attached confidential computations are submitted in support of the gas supply cost adjustments affecting volumes delivered to Black Hills Energy's customers on or after June 1, 2021. The attached Schedule A reflects spot market and gas purchase costs effective June 1, 2021.

This filing does not address incremental extraordinary gas supply and interstate natural gas pipeline costs related to the unique and extreme weather event experienced by Black Hills Energy during February.
