Dear Chairman Watermeier,

As Superintendent of Raymond Central Public Schools, I know what the students and teachers in Lancaster County need to thrive. One such necessity is high-speed broadband. Our current education system relies on the internet, to access their learning management system and materials and completing homework at home. Children who have low-quality, unreliable internet in their homes are inevitably left behind.

The Nebraskan government reports that only 65.3% of people in rural Lancaster have access to fiber and/or cable broadband. This is unacceptable. Thankfully, the Nebraska Broadband Bridge Program has the potential to close the digital divide in Lancaster County. I want this program to be as successful as possible. That's why I believe the Public Service Commission should award a grant in Lancaster County to Charter Communications in the coming cycle.

Charter is a well-regarded nationwide provider who is already well-established in our state. They serve numerous Nebraskan communities, including parts of Lancaster County. This allows them to extend their network quickly. Moreover, they have a track record of expanding broadband efficiently, particularly in hard-to-reach, rural areas.
