I agree to comply with all terms of the Nebraska Broadband Bridge Program, including the sharing of speed test data as required by the Protective Order in this matter, I agree to provide documentation to the Commission as required, including for Type 2 challenges, progress reports to the Commission every three months which demonstrate progress towards construction. I also acknowledge that if service is not provided to the project area within the required eighteen-month timeframe, the Commission will impose a civil penalty, and the challenging provider will be prohibited from submitting any applications or challenges within the Nebraska Broadband Bridge Program for the following two fiscal years.
