### 911 SSAC MEETING COVERS VARIETY OF TOPICS

From cybersecurity to Next Generation 911 (NG911) to the new funding model there were a lot of topics on the table at 911 Service System Advisory Committee's (911SSAC) May meeting.

For the past eight months the PSC and its consultant Mission Critical Partners (MCP) have been working with PSAPs statewide to build cybersecurity awareness and strengthen the security of the PSAP environment. At the May meeting MCP summarized the assessments indicating that Nebraska's PSAPs have a roadmap to strengthen the security of their environments.

PSC 911 Department Director Dave Sankey provided updates on regionalization and NG911. Sankey indicated that regionalization continues moving forward with a few remaining PSAPs finalizing their plans to join a region.

"With the migration to NG911 underway, it's an exciting time for public safety communications in Nebraska," *State 911 Director, David Sankey*.

NG911 migration also continues to progress. The South Central-Panhandle region was the first to migrate to the Emergency Services Internet Protocol Network (ESInet) with 21 of its 22 PSAPs connected. Four of the remaining six regions are on track to migrate to the ESInet in the late summer/early fall timeframe.

With the migration underway there was discussion on the new funding model and timing for PSAPs making the transition. The State 911 Department will conduct a webinar to assist PSAPs with navigating the new funding model as they move from a Legacy PSAP to a NG911 PSAP.

The next meeting of the 911SSAC will be held 1:00 p.m., Wed. August 31, at the PSC in Lincoln.



## 911 SSAC WELCOMES NEW MEMBERS

The 911SSAC welcomed some familiar faces to the committee during its May meeting.

As you just read, it is a busy time for everyone associated with 911 communications across the state. The migration of the seven PSAP regions across the state to the ESInet is underway, the cybersecurity assessments are complete and we are all working through the transition to the new NG911 funding model.

As we head into the summer months, a reminder of the nationwide transition to the 988 mental health and suicide crisis number. The rollout of the new three-digit number will take place in mid-July.

In Nebraska, calls to the National Suicide Prevention Lifeline will continue to be answered at Boys Town where call takers screen, and provide crisis intervention and referrals.

Moving to an easy-to remember three-digit number provides an opportunity for public safety to work together to better assist individuals who may be suffering a mental health crisis.

The state 911 department, the 911SSAC and MCP continue to assist the Department of Health and Human Services (DHHS) and the Department of Behavioral Health (DBH) with it implementation plan for 988 in Nebraska by helping to make the work flow as efficient as possible.

## Allocation Information Update

As the transition from legacy PSAPs to NG911 PSAPs continues across the state you'll want to pay special attention to your PSAP's funding allocation depending on where your PSAP is at in the transition process.

You will still be receiving a letter in the mail containing your PSAPs funding allocation and wireless ratio for July 1, 2022- June 30, 2023. Please make sure to share the information with your county clerk or treasurer.

You can also view funding allocations for Legacy PSAPs and NG911 PSAPs on the PSC website under the State 911 tab, on the PSAP page < <a href="https://psc.nebraska.gov/state-911/public-safety-answering-points-psaps">https://psc.nebraska.gov/state-911/public-safety-answering-points-psaps</a> > under the Allocation drop down.

#### **Wireless Audits**

In addition to the allocation letter, you should have also received an email containing a packet of audit information for July 1, 2021- June 30, 2022. The audit packet must be returned to the PSC State 911 department by October 15, 2022.
