#### LUMEN PROVIDES PROJECT UPDATE FOR 911 SERVICE SYSTEM ADVISORY COMMITTEE

With a mix of in-person and online participation, the 911 Service System Advisory Committee (911 SSAC) had a full agenda for its May 12 meeting.

On tap, an update from LUMEN on the NG911 Deployment Project. Lumen team members told the committee that the project was moving along well and that everything was on track to migrate the South-Central region to the NG911 platform in November. A kick-off meeting for Lumen, the State 911 Department and Metro Region representatives was held in mid-May.

State 911 Director Dave Sankey provided an update on ECaTs deployment and regionalization efforts, followed by updates from the committee's working groups. The 911 SSAC meeting held in May marked the first time Committee members have gathered in person since the Governor's Executive Order that allowed public meetings to be held virutually expired.

Despite the expiration of the Executive Order, not much has changed for meeting participants due to the legislature's passage of <u>LB83</u> which provides additional options for public meetings.

<u>LB83</u>, signed into law by the Governor on April 21, allows for public meetings to continue to be held virtually as long as at least one member of the Committee is present at the physical location of the meeting. It also makes it possible for committee members participating virually to vote on action items presented during a meeting.

As noted, we had a good mix of in-person and online participation during our May meeting and look forward to committee members continuing to participate through which ever means best suits their needs.

We also encourage PSAPs representatives, the public safety community and the public to attend our meetings either virutally or in person (as long as room capacity allows). We add our congratulations to Senior Dispatcher Shasta Starkey for being recognized as 2020 Dispatcher of the year by Impact Dispatch.


Starkey has worked in the city of Lincoln Emergency Communications Center for nearly eight years.


Does your PSAP have a plan in place should a crisis arise? Does that plan include a crisis communication component?



Please make sure to share the information with your county clerk or treasurer. Also, watch for an email in July containing a packet of audit information for July 1, 2020- June 30, 2021. The audit packet must be returned to the PSC State 911 department by Oct. 1, 2021
