9-1-1 SERVICE SYSTEM ACT PROGRESS REPORT

The Nebraska Public Service Commission (PSC) in February submitted its Progress Report on the 9-1-1 Service System Act (LB938) to the Appropriations and Transportation and Telecommunications Committees of the Nebraska Legislature

Submission of the report marks the first big step as the PSC Next Generation 9-1-1 (NG9-1-1) Department works to develop a plan to transition the state from an existing Enhanced 9-1-1 (E9-1-1) system to a NG9-1-1 System.

The PSC has retained Mission Critical Partners Inc. (MCP) to support development of the NG9-1-1 Master Plan and has established a stakeholder group comprised of representatives from public safety agencies, Public Safety Answering Points (PSAPs), State, Municipal, and County officials and organizations, wireline, wireless and Voice Over Internet Protocol (VoIP) service providers.

PSC TO HOLD WORKSHOP ON GEOGRAPHICAL INFORMATION SYSTEM (GIS)

A Geographic Information System (GIS), is an organized collection of computer hardware, software, geographic data and highly trained personnel assembled to efficiently capture, store, update, manipulate, analyze and display spatially enabled tabular data in interactive maps providing a visual representation of the world around us.

Simply put, accurate and timely GIS data is essential for an effective 9-1-1 system. For Next Generation 9-1-1 (NG9-1-1) GIS data is a critical component. GIS data will be the vehicle by which calls are routed and callers are located, making it vitally important the data be standardized, accurate, updated and maintained.



In an effort to better define technical standards, policies, system requirements, and funding priorities the PSC will hold a workshop on all things GIS. Comment and participation from all interested parties is welcome. The GIS Workshop will be held beginning at 10:00 a.m., Monday, May 1, in the Commission Hearing Room. A telephone bridge will also be available during the workshop for those wishing to participate via telephone.

"This is an opportunity to ask questions and gather detailed information about GIS and its relation to 9-1-1 in Nebraska," said Dave Sankey, State 9-1-1 Director. "We encourage everyone to participate and look forward to your input."

My how time flies! Just a reminder if your PSAP is requesting funding from the PSC the deadline for filing of the funding application **is April 15**. Here are a few key things to remember when filling out your funding application.

- Include call volumes
- Provide copies of all new contracts

Text to 9-1-1- Reimbursement

We want to make sure you get compensated. If your PSAP has paid a vendor for any <u>approved</u> Text-to-9-1-1 expenses, you must notify the Public Service Commission, 9-1-1 Department. In order to be reimbursed for the expense please provide proper documentation of costs.
