#### 911 SSAC HAS BUSY SPRING

It's been a busy spring for the 911 Service System Advisory Committee (911 SSAC). Committee members are meeting monthly as they ramp up efforts toward the implementation of Next Generation 911 (NG911) in Nebraska.

During meetings held in April, May, newly retained consultant Mission Critical Partners (MCP) helped to map out next steps. Tops on the list formation of working groups and leadership for the groups. A list of the working groups and their chairs can be found below. Working group guidelines were established and group kick-off meetings were held for the technology, GIS and funding working groups with first reports expected to be submitted to the Committee in July

Committee members also approved recommending the Commission move forward with pursing a contract for the ECaTs Management Information System (MIS) for all PSAPs funded by the PSC. The recommendation will go before the Commissioners for their approval during the month of July.

Having accurate, easy to access, informative reports is key to managing day-to-day operations in our Public Safety Answering Points (PSAPs). As we move forward as a state with the implementation of Next Generation 911 the 911 Service System Advisory Committee (911SSAC) is recommending providing the Management Information System (MIS) ECaTs to all state PSAPs funded by the PSC

The Emergency Call Tracking System or ECaTs works with all CPE providers compiling raw data into a clear-cut report detailing a PSAPs performance and future needs. As an example, the report provides information pertaining to call origination, call duration, peak call hours, calls on hold, calls answered and calls transferred.

While some of our PSAPs have MIS reporting, supplying all PSAPs with a single provider will put everyone on the same page when gathering essential data needed to effectively manage and operate our PSAPs.

On a statewide level, ECaTs will give us a better picture of what call volume looks like as we move forward with NG911. It will allow us to determine if calls are being routed properly through the ESInet and if they are reaching PSAPs in a timely manner. The ability to access this information in near real time will provide another layer of security in managing the interconnected networks on the statewide system.

I would like to thank the ECaTs working group for all of its hard work and the 911 Service System Advisory Committee (SSAC) for recommending the purchase. ## **PROCLAMATION HONORS PUBLIC SAFETY TELECOMMUNICATORS**

Representatives from Public Safety Answering Points (PSAPs), public safety agencies and the Nebraska Public Service Commission (PSC) joined Governor Pete Ricketts for the signing of a proclamation recognizing our state's Public Safety Telecommunicators/Dispatchers.

This is the second year the Governor has signed a proclamation raising awareness of National Public Safety Telecommunicators week (April 14-20) and honoring the dedicated, hard-working Public Safety Telecommunicators/Dispatchers in the state of Nebraska.

"The commitment of our public safety telecommunicators/dispatchers has never been more evident than during the recent extreme weather experienced in our state, said Commission Chair Mary Ridder. "This proclamation is just a small way of saying thank you for the life-saving role they play not only during disasters, but every day."

The PSC will provide a copy of the signed Proclamation to Nebraska PSAPs for display. State 911 Field Coordinator James Almond will be distributing copies during his PSAP visits. #### **E911 ADVISORY BOARD MEETS IN LINCOLN**

Election of officers and approval of funding requests were the order of business during the second quarter meeting of the E911 Advisory Board. Ike Brown of McCook was chosen as the Board's new chair and Stu DeLaCastro of Sarpy County will serve as Vice-Chair. The board also welcomed new member, Lt. Steven Reeves of North Platte.

Following the election of officers, State 911 Director Dave Sankey introduced the 911 Department's new Field Coordinator James Almond and provided updates on legislative bills and regionalization. The board then approved 17 PSAP funding requests and 4 text-to -911 requests.

## Funding Applications Processed- Audit Information Provided

Funding applications for 2019-2020 have been processed by the State 911 Department. We would like to thank everyone for their hard work in getting the information to us in a timely manner.

Keep your eye out for a letter in the mail containing your PSAPs funding allocation and wireless ratio for July 1, 2019- June 30, 2020. Please make sure to share the information with your county clerk or treasurer. You can also view funding allocations on the PSC website under the State 911 tab, on the PSAP page < <a href="https://psc.nebraska.gov/state-911/public-safety-answering-points-psaps">https://psc.nebraska.gov/state-911/public-safety-answering-points-psaps</a> > under the Allocation drop down.

In addition to the allocation letter, you should have also received an email containing a packet of audit information for July 1, 2018-June 30, 2019. The audit packet must be returned to the PSC State 911 department by Oct. 1, 2019
