911 SSAC HEARS WORKING GROUP UPDATES

Presentations from five working groups capped off the final meeting of 2019, for the 911 Service System Advisory Committee (SSAC)

Much of the attention focused on the funding working group. Chair Jon Rosenlund detailed the key funding recommendations developed by the group over the past year. He stressed, the way 911 is currently funded in the state, will need to change to accommodate a Next Gen environment. The presentation drew lively discussion from the committee. It was determined a period of time was needed for committee members to provide comment and suggestions to the working group before a vote on the funding recommendations was taken.

Committee members also heard updates from the technology working group which continues its efforts to secure a Request For Proposal (RFP) for the ESInet and Core Services.

"Having a funding plan identified is key to moving forward with the implementation of NG 911," State 911 Director, David Sankey."

The GIS working group provided information on its planned regional workshops. The first workshop was held in October in the Southeast Region. The workshops are designed to reconcile regional GIS boundaries. A second workshop is planned for mid-December in the South Central Region. The training working group held its kickoff in October. The group has conducted a training survey as it works to develop and implement a foundation for minimum training standards and certification for each level of PSAP employees. Stu DeLaCastro, has been identified as the chairperson for the operations working group. Its objectives include interconnectivity, policies and procedures and NG911 best practices.

State 911 Department Updates Legislative Committees on NG911

The joint hearing provided an opportunity to let lawmakers know the progress being made as the state works toward implementation of NG911. Director Sankey, gave an overview of the process and highlighted the efforts of the 911 Service System Advisory committee and its working groups.

SARPY COUNTY JOINS METRO REGION

Sarpy Count Emergency Communications has successfully merged into the metro region joining together with Douglas, Washington & Pottawattamie Counties in August.

The County was authorized by the PSC to utilize 911 Service System Funds to complete a phone system upgrade project, making for smooth transition into the metro region.

In addition to the phone system upgrade, becoming a part of a region provides Sarpy County with an additional level of redundancy, a big step in providing a more advanced level of service to the public.

It has been an exciting fall for public safety communications in the state with the opening of three joint communications centers.

An October grand opening was held for the newly built \$3.4 million dollar Grand Island-Hall County Emergency Management & Communications Center. The 10,664 square foot facility co-locates Emergency Management with the Grand Island & Hall County Communications centers.

After more than a decade in the making the City of Columbus/Platte County joint 911 Communications center is up and running. The newly renovated 911 center located in the Columbus Municipal Airport, Administration building will provide a single location for dispatchers from both the city and county to work as one.

In York County, a recently completed expansion of the York County Courthouse, is the new home of the York Police Department & York County Emergency Communications Center. The new addition with a cost of two million dollars is designed to withstand an F5 tornado.

NEBRASKA APCO/NENA CONFERENCE HELD IN LINCOLN

The Cornhusker Marriott hotel in Lincoln was the site of the Nebraska APCO/NENA chapter fall conference, Oct 21-23.

With the theme "Dispatch Detectives Get Clued In", participants in the three-day conference were treated to a detailed wrap up on Nebraska Task Force 1's Response to the 2019 Flood, as well as a variety of educational sessions to include: Cyber Security: Challenges & Opportunities for NG911; PSAP Performance Metrics; and Got Indoor Maps?

PSC State 911 Department members played an active role in the conference, with director Dave Sankey and GIS specialist Kea Morovitz participating in the 911 Goes to Lincoln breakout session. They provided updates on the current status of the state's efforts to implement NG911 in Nebraska as well as the importance quality GIS information plays in the process. Those attending also received updates on FirstNet and the Nebraska Emergency Management Agency (NEMA)



The 911 Advisory Board held two meetings (October & December) to close out 2019. During the October meeting, held in conjunction with the APCO/NENA conference, board members voted to recommend the PSC leave the 911 wireless surcharge fee at the current \$0.45 for the next year. Funding requests were also approved for 10 Public Safety Answering Points (PSAPs).

The December meeting was held at the Nebraska Public Service Commission, where board members approved five funding requests.

911 WIRELESS ADVISORY BOARD ACTIVITY



911 ASSISTANT DEVICES ALERT

The State 911 Department was recently contacted by one of our PSAPs with a heads-up about 911 assistant devices. The PSAP, received a call from someone who was making a test call on a pendant device called "Guardian 911 Alert Plus". The call came in as WPH2 and plotted an address. The pendant however was connected to a throw away cell phone so there was no valid callback number. The concern for the PSAP was, if the individual pushed the button but wasn't able to talk, the PSAP would have difficulty ascertaining the problem or locating the caller.

In doing some checking, the PSAP found these types of devices are available for sale over the internet by various makers and with various designs. The issues raised by the PSAP are valid concerns, if the device in question is not connected to a subscription service, with a call center (such as Lifeline).

We want to thank our friends at Keith County 911 for raising awareness of this issue, and encourage all PSAPs, to be aware of these devices and discuss how to deal with them should a call come in.

TELECOMMUNICATORS ATTEND TRAINING IN G.I.

Twenty-four public safety telecommunicators/dispatchers from across the state attended the second Basic Public Safety Telecommunicator Training course put on by the PSC state 911 department.

The weeklong course held at the Nebraska Law Enforcement Training Center in Grand Island was taught by state 911 department field coordinator James Almond. Those in attendance, received training to include interpersonal communications, call process, traditional telephone technology, Next Generation 911, Computer-Aided Dispatch (CAD) and related technologies and more.

"It was a great week, with a very engaged group," Almond said, "I am excited for these individuals to return to their PSAPs so that they can apply what they've learned.

We're Going Paperless!

The PSC State 911 Department is working on going paperless and our PSAPs are a big part of the process. Beginning January 1, 2020, **all PSAP documentation** to include, funding applications, fund usage requests, and audit information will need to be sent into our department electronically. Some of you have already made the transition, thank you. For those of you who have not, here are some quick tips;

- Complete all documentation (please remember to sign your documents)
- Scan all documentation
- Email all documentation to <u>psc.psap@nebraska.gov</u>

Just a reminder, when sending in your 2020-2021 funding applications, please include **call volumes from the entire year** either fiscal or calendar, whichever your PSAP works off of (call data from MIS or ALI Retrieval forms are acceptable documentation for call volumes). Also, **include all newly signed contracts** from 2019.

Fund Usage Request Deadline

If your PSAP will be submitting a Fund Usage Request for approval by the 911 Wireless Advisory Board it's important to remember the request must be received **two weeks prior to the meeting date**. If your request isn't received by the deadline, it will not be placed on the agenda and you will need to wait for the next board meeting for approval. Also please remember **to sign your documents** before scanning and sending them in electronically.
