## STATE ISSUES RFP FOR ESINET AND CORE SERVICES

The long awaited Request for Proposal (RFP) for a statewide ESInet and Core Services for Next Generation 911 (NG911) in Nebraska has been released.

“The ESInet and Core Services are the heart of NG911 implementation,” said David Sankey, State 911 Director. “The release of the RFP is a major step forward toward accomplishing our goal.”

The RFP which was released by State Purchasing on March 17, states that the Public Service Commission is seeking a vendor(s), to provide an Emergency Services Internet Protocol network (ESInet) and Next Generation 911 Core Services to connect the Public Safety Answering Points (PSAPs) across the state to the Statewide 911 Service System.

## WIRELESS 911 ADVISORY BOARD HOLDS FIRST MEETING OF NEW YEAR



Wednesday, February 12, marked the first meeting of the New Year for the Wireless 911 Advisory Board. The meeting was held in Lincoln in the hearing room of the Nebraska Public Service Commission.

First order of business was to elect leadership positions for the New Year. Steve Reeves, of North Platte was elected to serve as advisory board chair, while Shelly Holzerland of Dodge County will fill the role of vice-chair.

The board then heard information on Legislative Bill (LB) 1156. The bill introduced by Senator Vargas (District 7) Omaha, would require the State Board of Education to develop a statewide school panic button program. Steve Reeves provided insight into use of the Panic Button program in the North Platte school district. An update was also given by State 911 Director David Sankey on PSAP regionalization efforts as the state works towards the implementation of NG911.

Approval was given to six separate PSAP funding requests. The approved requests were from the cities of Alliance & Hastings and the Counties of Kimball, Nuckolls, Polk and York.

The next meeting of the Wireless 911 Advisory Board was schedule for 10:00 a.m., on Wednesday, May 13.

## WIRELESS 911 ADVISORY BOARD MEMBER UPDATE

Nebraska Governor Pete Ricketts recently appointed Timothy Higgins of Kearney to serve a three-year term on the Wireless 911 Advisory Board. Higgins, a Buffalo County Board member fills a vacancy on the board for a County Official or Employee.

The Governor also reappointed Issac Brown of McCook and Carolyn Petersen of Valentine to the Advisory Board.

Brown, who has served on the board for 15-years and Peterson who was appointed last year to fill a vacant public member position, will each serve a three-year term.

In addition to the opportunity to network with other telecommunication specialists the 36 attendees received training in customer service, complacency, the opioid addiction crisis and PTSD in veterans. A presentation on Rapid SOS was also provided.

### It Is Funding Application Time!

The first of the year is always an exciting time for the PSC State 911 Department as we prepare for a new year of funding applications for 2020-2021.

Just a reminder, funding applications for all PSAPs and WSPs receiving monies from the PSC are due by April 15, which falls on a Wednesday this year. An email from the PSC was sent to all PSAPs with an application which includes a call ratio summary sheet. WSPs that have previously applied also should have received an email with an application.

A few key items to remember when filling out your funding applications include:


- Call volumes (call data from MIS or ALI Retrieval forms are acceptable documentation for call volumes)
- Provide copies of all new contracts.

You should have gotten your email with the funding application by the first part of March. If you haven't, please reach out to us @ [psc.psap@nebraska.gov](mailto:psc.psap@nebraska.gov) and we'll work with you to get the information you need.
