The Sioux County Board of Commissioners met for a special meeting at the Sioux County Courthouse meeting room on June 21, 2022, a 9:00 a.m. with the following present: Commissioners Hal Downer, J.W. Geiser, and Josh Skavdahl. County Clerk

Michelle Zimmerman and Road Superintendent Jim Phipps were also present. Reference was made to the Open Meeting Laws posted in the meeting room.

Motion made by Geiser seconded by Downer to approve the agenda. On roll call vote, Downer, yes; Geiser, yes; Skavdahl, yes. Motion carried.

The Pledge of allegiance was recited, J.W. Geiser led the meeting in prayer.

Allen Jordan gave an update on the Veteran's Service Office. Lee Engebretsen wants to step down from that position. A Veteran's Service Board needs to be established. Engebretsen, Glen Petersen, Bill Skavdahl, Philip Filing, Dennis Murphy, Bordner Munson, and Mike Kesselring are all interested in serving on the board.

Mike Kesselring stated that with the number of veterans being served, he would like to see a budget line item for expenses. Motion made by Geiser, seconded by Downer to appoint the board. On roll call vote, Geiser, yes; Downer, yes; Skavdahl, yes. Motion carried.

A recommendation for Veteran's Service Officer will be made by the Board at the July 1 Commissioner meeting.

Jerry Berggren, Berggren Architects, gave an update on the courthouse window project. The paperwork is ready to be sent to the State Historical Preservation Office for their review and approval prior to sending out to bid. Randall Weber has made an assessment of each window. He had several recommendations regarding the project.

Resolution 2022-6 was reviewed. The Resolution is to transfer \$5,611.14 from the Jail Budget to the Sheriff Budget due to over-expending funds within the Sheriff Budget. Motion made by Downer, seconded by Geiser to approve the Resolution. On roll call vote, Downer, yes; Geiser, yes; Skavdahl, yes. Motion carried.

Joni Jespersen, Mobius Communications discussed a grant to get broadband into Sioux County in the Vogl Loop area. Motion made by Geiser, seconded by Downer to contribute \$13,000 as a match with Mobius toward the project. On roll call vote, Geiser, yes; Downer, yes; Skavdahl, yes. Motion carried.

Motion made by Geiser, seconded by Downer to designate the state print service for the printing of

postcards for joint public hearings. On roll call vote, Downer, yes; Geiser, yes; Skavdahl, yes. Motion carried.

Motion made by Downer, seconded by Geiser to approve the contract with USDA, APHIS for predator control services in the amount of \$34,050.00 for July 1, 2022, through June 30, 2023. On roll call vote, Downer, yes; Geiser, yes; Skavdahl, yes. Motion carried.

Jim Phipps gave an update on current road work being done.

There being no further business to come before the Board, the meeting adjourned at 10:40 a.m.
