In addition, each Applicant may be assessed additional costs and expenses reasonably attributable to the application consistent with Neb. Rev. Stat. § 66-1840. Notice of the application will be published in the Daily Record, Omaha, Nebraska.</p> <p>Applicants must notify the Commission during the pendency of the certification request of any material change in the representations and commitments required by this subsection within 14 days of such change.</p> <p>Questions should be directed to the Natural Gas Department of the Nebraska Public Service Commission at (402) 471-3101.</p>
