

### Nebraska Choice Program

- Eligible Customers
  - All customers residing in Rate area 5 (Western 2/3 of Nebraska)
- 2023 Choice Program Dates
  - March 30, 2023 Choice Program packets are sent out to customers
  - April 6, 2023 April 26, 2023 (Selection Period)
- What if a customer doesn't make a selection?
  - Customers will be assigned a supplier or will default to the last supplier selected
  - Non-selecting customers will be given a "default rate", which is determined by the suppliers after the selection period ends.

- Suppliers (7)
  - ACE (Public Alliance for Community Energy)
  - Black Hills Energy Services ("BHES")
  - Constellation Energy
  - Symmetry Energy
  - Uncle Franks Energy Services
  - Vista Energy Marketing
  - Wood River Energy, LLC
- Black Hills Energy (Administrator): BHE does not sell natural gas as a supplier in Rate Area 5

Note: BHES is a licensed Competitive Natural Gas Provider ("CNGP") which offers competitive supply services and is legally separate and distinct from Black Hills Energy, the regulated Choice Program administrator.






#### 2021-2023 Nebraska Eligible by Area




#### 2021-2023 Nebraska Active Ballots by Class



#### 2021-2023 Comparison of Selections for Same Supplier vs Changing Suppliers




#### Total Number of Customers by Supplier (2022 & 2023)




#### 2023 Customer Supplier Selections by Class

#### Commercial Customers Selections (2022 & 2023)









#### 2022 & 2023 Lowest Rates by Region





#### 2022 & 2023 Highest Rates by Region
