CoAxis Energy Company will sell natural gas using liquefied natural gas to poultry farms in Eastern Nebraska. The natural gas is purchased off of Northern Natural Gas company's interstate pipeline and delivered to CoAxis owned LNG facilities for regasification to natual gas. The natural gas is injected into Black Hills Energy distribution pipelines and transfered to the individual farms. CoAxis Energy Company will sell to the customer at each individual poultry farm. CoAxis Energy has partnered with KALM Energy, LLC to provide natural gas service to each customer with LNG. CoAxis Energy Company will bill the customer under contracted pricing and pay Black Hills Energy for the distribution fees. CoAxis Energy Company will use contract pricing with natural gas suppliers for purchasing the commodity.


