COMMENTS OF THE RURAL INDEPENDENT COMPANIES

I. INTRODUCTION.

The Nebraska Rural Independent Companies ("RIC")¹ hereby submit these Comments in response to the Nebraska Public Service Commission's (the "Commission") Order Opening Docket and Seeking Comment entered herein on August 28, 2018 (the "Order"). RIC appreciates the opportunity to provide this submission and looks forward to continuing participation in this docket and other pending dockets regarding the Nebraska Universal Service Fund contribution reform.

II. THE COMMISSION HAS THE LEGAL AUTHORITY TO SUBJECT PREPAID WIRELESS TELECOMMUNICATIONS SERVICES TO A CONNECTIONS-BASED NEBRASKA UNIVERSAL SERVICE FUND SURCHARGE.

Among the responsibilities delegated to the Commission by the Nebraska Legislature with regard to the Nebraska Universal Service Fund ("NUSF") is that the Commission "[s]hall require every telecommunications company to contribute to any universal service mechanism established by the commission pursuant to state law." In connection with the performance of

the foregoing responsibility, the Commission "[s]hall have authority and power to issue orders carrying out its responsibilities . . ." (emphasis added)³ Further, in the Legislature's declaration of policy regarding the NUSF, among the principles enumerated is that "[a]ll providers of telecommunications should make an equitable and non-discriminatory contribution to the preservation and advancement of universal service."

Prepaid wireless telecommunications service has been defined by the Legislature to be a telecommunications service.⁵ Further, for the purposes of the Prepaid Wireless Surcharge Act, provider "means a person that provides prepaid wireless telecommunications service pursuant to a license issued by the Federal Communications Commission." As such, the Commission has the authority, by and through its orders, to require providers of prepaid wireless telecommunications service to make an equitable and non-discriminatory contribution to the NUSF, and to implement a connections-based mechanism for such contribution.⁷

III. IN ORDER TO ESTABLISH AN EQUITABLE AND NON-DISCRIMINATORY NUSF CONTRIBUTION FOR PREPAID AND POSTPAID WIRELESS TELECOMMUNICATIONS, THE COMMISSION SHOULD ADOPT THE APPROACH FOR ASSESSMENT OF A CONNECTION-BASED SURCHARGE AS WAS TAKEN IN PROPOSED AM 1906 TO LB 157.

In the Commission's August 7, 2018 Order entered in Application No. NUSF-111/PI-211, the Commission found that a connections-based contribution mechanism should be adopted

"on residential wireline, wireless and VoIP services." The Commission proceeded to further find that the connections-based surcharge should initially be set at \$1.75 per month per connection. Although the Commission initially imposed a revenues-based surcharge of 6.95 percent on prepaid wireless, the Commission also declared that it would open "a subsequent proceeding to determine how a connection-based contribution mechanism as defined in NUSF-112 can be established for prepaid wireless telecommunications service providers." Of course, the instant docket was opened pursuant to the above-quoted statement of intent.

In order to fulfill the statutory directive that all providers of telecommunications service shall make an equitable and non-discriminatory contribution to the NUSF, RIC recommends that the Commission should enter an order in this docket that (a) vacates the finding made in Application No. NUSF-111 that prepaid wireless telecommunications service shall be subject to a revenues-based surcharge of 6.95 percent, except for prepaid business wireless telecommunications service; and (b) implements a connections-based surcharge for prepaid residential wireless telecommunications service calculated on the basis of a percentage calculated by dividing (i) the amount of the surcharge certified by the commission (in this instance \$1.75/connection/month) by (ii) fifty.

The Commission should thereafter certify to the Nebraska Department of Revenue ("NDOR") that it has established a connection-based contribution mechanism applicable to prepaid residential wireless telecommunications service and request that the NDOR impose and

collect this surcharge from prepaid wireless telecommunications service providers in accordance with the procedures set forth in Section 86-903 of the Nebraska statutes.
