**Q. PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.**

A. My name is Tom Shoemaker. My business address is 611 Patterson Street, Cambridge, Nebraska 69022.

**Q. BY WHOM ARE YOU EMPLOYED?**

A. I am the Executive Vice President of the Applicant in these proceedings, Pinpoint Wireless, Inc. d/b/a Blaze Wireless ("Blaze").

**Q. HOW LONG HAVE YOU BEEN EMPLOYED BY BLAZE, AND WHAT ARE YOUR GENERAL DUTIES?**

A. I have been employed by our parent company Pinpoint Holdings since March of 2001. My primary duties are the day to day oversight of all operating functions of the company, its staff, and its day to day management.

**Q. WHAT IS THE PURPOSE OF YOUR PREFILED DIRECT TESTIMONY IN THIS PROCEEDING?**

A. My prefiled direct testimony addresses three topics. In Section I, I provide background and introductory information about Blaze and its parent entities. In Section II, I affirm that the information provided in Blaze's Application Requesting Support from the Nebraska Universal Service Fund Broadband Program (the "Blaze Application") is true and correct to the best of my knowledge. In Section III, I explain Blaze's position with respect to the distribution of available funds from the NUSF Broadband Program.

**Q. ARE YOU SPONSORING ANY EXHIBITS IN CONNECTION WITH YOUR DIRECT TESTIMONY?**

A. Yes. To the extent that those materials are not otherwise made part of the record in these proceedings, I am sponsoring the Blaze Application and all exhibits related thereto.

**I. INTRODUCTION**

**Q. PLEASE DESCRIBE BLAZE.**

A. Blaze<sup>1</sup> is a Nebraska corporation and is authorized to conduct business in the State of Nebraska. The Commission designated Blaze as an eligible telecommunications carrier in the State of Nebraska by Order dated June 26, 2012.<sup>2</sup> Blaze is a subsidiary of Pinpoint Holdings, Inc., a diversified holdings company of telecommunications entities.

**Q. PLEASE DESCRIBE BLAZE'S CURRENT GENERAL SERVICE AREA AND SERVICE OFFERINGS.**

A. Blaze currently offers service in the southwest portion of Nebraska. We are currently focused on an eight (8) county area to supply both voice and data services. Currently Blaze offers mobile voice, mobile data, fixed voice and fixed data services to its customers. It is Blaze's intent to offers services wherever our customers live, work, and play.
