Windstream submits the following project for the Commission's consideration of NUSF-99 broadband funding, to be constructed upon funding approval, using funding available from the 2017 funding allocation.

 Fiber fed DSLAMs to serve a portion of the Northern area of the Octavia, NE ILEC Exchange (full funding requested)

This area of the Octavia Exchange is not currently offered broadband service above 4Mbps. This project intends to address these customers by placing a fiber fed DSLAM within an appropriate distance to provide a <u>minimum</u> of 10Mbps up to 100Mbps download speeds.

- The project will place a DSLAM site at a remote location approximately 3 miles north of the Central Office, along with fiber cable placed from the nearest available existing fiber splice.
- The remote DSLAM will provide the broadband connection to the customers, and have fiber backhaul to the Central Office location.

Windstream projects the total deployment costs for this project is \$137,295 and Windstream is requesting Nebraska Universal Service Funding of the full amount, not including ROW and IDC. Windstream is requesting that the funding for this project be applied against the remaining 2017 funds allotted to Windstream.
