• Fiber-to-the Prem to serve a significant portion of the Bellwood, NE ILEC Exchange

This area of the Bellwood Exchange is not currently offered broadband service above 10Mbps. This project intends to address these customers by placing fiber-to-the-prem to provide symmetrical download and upload speeds of 1000Mbps.

- The project will place approximately 45 miles of fiber to enable symmetrical FttP services.
- The installation and use of optical equipment within the central office to provide direct service to individual residences and businesses

Windstream projects the total deployment costs for this project is \$3,519,144 and Windstream is requesting Nebraska Universal Service Funding of \$3,519,144, not including ROW and IDC. Windstream is requesting that the funding for this project be applied against the remaining 2018, 2019, and 2020 funds allotted to Windstream.

Windstream Response:

Attached Checklist Item #6 provides a listing of the retail pricing for the broadband services Windstream will be offering in the proposed service areas. This price list is consistent with Windstream pricing for similar services in other Nebraska exchanges.
